BUSINESS MEETING MINUTES
JULY 18, 2023 – 7:00 pm**

I Meeting called to order

The Scott Township Board of Supervisors held their monthly business meeting on July 18, 2023 at 7:00 pm at the Joe Terry Civic Center, 1038 Montdale Road, Scott Township PA 18447. The meeting was opened with the Pledge of Allegiance by Supervisor Giannetta. Supervisor Brenzel was on speakerphone and Supervisor Russell was absent. Guest in attendance was Carl Ferraro. Diane Dolinsky was watching from home taking minutes.

***Prior to the start of the meeting, Joseph Rovinsky from Lackawanna County came to hold a public hearing for the Community Development Block Grant (CDBG) program is. He explained that the township has \$167,940 in CDBG money from past years. This is the source of income being used for remodeling of the rest rooms.


IX **General Public Comment**
