They say it is too long, it is only 200 hours. We just have no staffing. We have an ambulance but no EMT. He explained how 911 works. Right now you need an EMT and a certified driver in the seat. We just don't have any members. If anyone would like to volunteer please come forward. Supervisor Giannetta said maybe it would be beneficial to meet and have a discussion on what we can do.

- Thanked the Board of Supervisors and the public for listening to him speak regarding the Dollar General.


